Bruce told about the former Y council's trails committee and what they had done. He has all that information on file. Nominations can be made to the MSB annually, first to the Mat-Su Parks & Rec. Advisory Board, then to the Planning Commission, then on to the Borough Assembly. The MSB recreational trails plan is available online.
